# Minutes from November 4, 2019 monthly meeting

Meeting called to order at 18:00 by Russ Driskell

One addition to agenda under Announcements. jona motioned to approve amended agenda, seconded by Deke. All approved.

No minutes from last meeting.

Jessica introduced Jeremy Dear, sales rep for Rosenbauer with Artesia. He can get some demo trucks to show us.

Jessica introduced Bill Mack, District Sales Manager for Akron & Hale. He showed some new products, handed out brochures and showed a PowerPoint on IDEX Corp. re: the new SAM auto pump system (including demo instructional videos.)

## Reports:

WPFD – structure fire, 80 year old cabin fully involved. Requested lots of water tenders. Many usual mutual-aid resources were already committed to a fire in Costilla.

RRFD – assisted with above fire, had 29 calls total including 2 dumpster fires, CO alarms, a roll over and an abandoned campfire. Deke is new Chief. The Capitol Christmas Tree will be cut near town Wed. 11-6-19 – meet at the Community Center at 09:00 to attend.

AFFD – 26 calls total including 2 chimney fires, CO alarms, a fatal plane crash and mutual-aid to a WL fire in Hidden Lake.

LVFD – mostly EMS calls and CO alarms. Also responded mutual-aid to the grass fire in Costilla (under 2 acres but approx. 4 separate piles of lumber/debris.

SBRVFD – dispatched to a different plane crash that turned out not to be in their area (it took several days for rescuers to reach the site.) a CPR call with the closest ambulance coming from Las Vegas, grass fires in Cleveland & Guadalupita and mutual-aid to the WL fire in Hidden Lake.

RFFD – 6 calls total including a cement mixer on its side, it took 7  $\frac{1}{2}$  hours to get the truck partially unloaded and righted, also while the highway was closed a couple came through with the lady in active labor (the wreckers unhooked to let them through.)
